

Using DBT PE with Autistic Individuals

Description

DBT PE providers are trained to work with clients with PTSD who have complex clinical presentations, and successful treatment relies heavily on solid case formulation skills. But what about when the client is autistic? Mental health providers often lack training in autism and are unsure if or how to modify evidence-based treatments effectively for autistic individuals. In addition, many clinicians are not well-trained in neurodiversity-affirming approaches to treatment and case formulation. Of particular relevance to DBT PE, it is important for clinicians to consider how being neurodiverse in a neurotypical world can result in repeated experiences of traumatic invalidation. In this webinar, Dr. Ritschel will provide a broad overview of autism, including the strengths and challenges associated with being autistic in the modern world. Next, she will discuss ways in which treatment can be adapted to be more effective and affirming for autistic individuals based on their learning styles, sensory sensitivities, and areas of interest. She will review the existing literature on recommended guidelines for treating trauma and using exposure-based techniques with autistic clients. Lastly, she will discuss how to apply these principles when using DBT PE with autistic clients.

Learning Objectives

As a result of this training, participants will be able to:

- 1. Describe two or more characteristics of autism that should be taken into account when considering or using DBT PE with autistic clients.
- 2. Describe three or more potential modifications to DBT PE that may make it more accessible or effective for autistic clients.
- 3. Understand how a neurodiverse identity can be conceptualized through the lens of traumatic invalidation.

Who Should Attend

This webinar is intended for mental health professionals and trainees who are very familiar with DBT and DBT PE. Some familiarity with autism is helpful, but not required.

Instructor

Lorie Ritschel, PhD earned her doctorate in Clinical Psychology from the University of Kansas, and she completed postdoctoral fellowships at Duke University Medical Center and Emory University School of Medicine. She is a co-founder of the Triangle Area Psychology Clinic (TAP), an outpatient clinic in Durham, NC that specializes in DBT and other empirically supported treatments for adolescents, adults, couples, and families. At TAP, Dr. Ritschel co-directs the clinical training program for graduate students and postdoctoral fellows. In addition, she is a faculty member in the Department of Psychiatry of the University of North Carolina at Chapel Hill School of Medicine, where she teaches empirically-supported treatments to residents and consults to the UNC TEACCH Autism Program. Dr. Ritschel is a certified DBT therapist through the DBT-LBC and is an expert trainer of DBT and the DBT Prolonged Exposure protocol. She provides training and consultation in CBT, DBT, PE, and Behavioral Activation as well as educational trainings in self-injury, suicide, borderline personality disorder, mood disorders, mindfulness, and hope. She is particularly passionate about working with emotionally dysregulated adolescents and their families.
